ORDINANCE NO. 25-7-5

An ordinance to provide for the installation of "**ALL-WAY STOP**" signs at the intersection of Lorraine Street and Amie Street, in Gabriel Heights Subdivision, in Destrehan.

WHEREAS, the St. Charles Parish Code of Ordinances, Chapter 15 Motor Vehicles and Traffic provides for the installation of traffic control signs; and,

WHEREAS, the installation of "All-Way Stop" signs will significantly reduce the possibility of accidents at this intersection by mitigating the risk navigating at the intersection on Lorraine Street and Amie Street; and,

WHEREAS, it is the desire of the Parish Council to authorize the installation of "**ALL-WAY STOP**" signs at the intersection of Lorraine Street and Amie Street, in Gabriel Heights Subdivision, in Destrehan due to safety concerns.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That there is hereby established "**ALL-WAY STOP**" signs at the intersection of Lorraine Street and Amie Street, in Gabriel Heights Subdivision, in Destrehan.

SECTION II. That the Department of Public Works is hereby authorized to erect and maintain said "**ALL-WAY STOP**" signs.
