THIS AGREEMENT, made this Agreement, made this day of January, 2002, by and between the St. Charles Parish Council (hereinafter called "Owner") and Ridgeway Construction, Inc. doing business as a corporation, (hereinafter called "Contractor").

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned:

1. The Contractor will commence and complete the construction of:

Bid items 1 (\$109,400.00), 2 (\$8,000), and 3 (\$2,500.00) which consists of installation of a 12" PVC C900 Water main in lieu of an existing 8" main. Associated construction includes valve and fire hydrant installation as well earthwork, testing, and seeding and fertilizing as shown on the project plans and specifications.

- 2. The Contractor will furnish all of the material, supplies, tools, equipment, labor and other services necessary for his construction and completion of the project described herein.
- 3. The Contractor will commence the work required by the Contract Documents on the date specified in the Notice To Proceed and will complete the same within 60 calendar days thereafter unless the period for completion is extended otherwise by the Contract Documents.
- 4. The Contractor agrees to perform all of the Work described in the Contract Documents for the sum of <u>One Hundred Nineteen</u>

 Thousand Nine Hundred Dollars and No Cents (\$ 119,900.00), Payable in current funds, subject to additions and deductions, if any, as provided in the Contract Documents.
