- WHEREAS, the PPI guides outreach for the Flood Damage Prevention Program in a way that is credited by the Community Rating System of the National Flood Insurance Program; and,
- **WHEREAS**, the Flood Aware Committee reviews the Program for Public Information document annually and adjusts as needed; and,
- WHEREAS, the Community Rating System provides for updates to the PPI to be adopted as an addendum to the original document; and,
- WHEREAS, the St. Charles Parish Council wishes to promote sound floodplain management by supporting the goals of the outreach projects in the PPI.

NOW, THEREFORE, BE IT RESOLVED THAT THE ST. CHARLES PARISH COUNCIL, acting as the governing authority of the Parish, authorizes the adoption of the Floodplain and Stormwater Management Program for Public Information, Addendum A-5 Year Update to the 2020 PPI.
