ORDINANCE NO. <u>14-11-3</u>

An ordinance to authorize the Parish President to make partial settlement in the matter entitled "Wallace C. Drennan, Inc. vs. St. Charles Parish, et al", 29th Judicial District Court, No. 77452.

WHEREAS, Wallace C. Drennan, Inc. filed a Petition for Mandamus to contest the issues in connection with the St. Charles Parish Public Works Project known as Canal #10 Drainage Improvements, Project No. P090201.2.; and,

WHEREAS, the parties have further agreed to reserve their respective rights in connection with the remaining litigation.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the Parish President of St. Charles Parish is hereby authorized to execute a Partial Settlement Agreement, and pay to Wallace C. Drennan, Inc. the sum of ONE HUNDRED FIFTY-ONE THOUSAND THREE HUNDRED FORTY-SIX AND 14/100THS (\$151,346.14) DOLLARS.

PARTIAL SETTLEMENT AGREEMENT

This Partial Settlement Agreement (the "Agreement") is made, effective as of November 2014 (the "Effective Date") by and among: Wallace C. Drennan, Inc. ("Drennan") and St. Charles Parish ("SCP") and V.J. St. Pierre, in his capacity as President of St. Charles Parish ("St. Pierre"). Drennan, SCP, and St. Pierre may be referred to from time to time herein as the "Parties".

WHEREAS, a dispute has arisen among the Parties, as more fully set forth in the Petition for Writ of Mandamus filed by Drennan in the Twenty-Ninth Judicial District Court for the Parish of St. Charles, styled *Wallace C. Drennan, Inc. v. St. Charles Parish and V.J. St. Pierre in his capacity as President of St. Charles Parish*, No. 77452 (the "Mandamus Lawsuit"); and

WHEREAS, the Parties desire to resolve the aforementioned Mandamus Lawsuit in the manner and to the extent described herein;

NOW THEREFORE, the Parties agree as follows:

- (a) SCP will pay to Drennan, within thirty (30) days of the execution of the Agreement, One Hundred Fifty-One Thousand Three Hundred Forty-Six Dollars and Fourteen Cents (\$151,346.14).
- (b) It is further the intent of the Parties that the payment recited in paragraph (a) above is consideration for Drennan's agreement to dismiss, without prejudice, the Mandamus Lawsuit.
- (c) It is further the intent of the Parties that the payment recited in paragraph (a) above is intended to resolve Drennan's claim for payment related to the items set forth on Exhibit 1 hereto.
- (d) The Parties agree that and that the resolution contemplated herein of the claims in the Lawsuit shall not function as a waiver or admission of any allegations, claims, or defenses asserted in the Petition for Damages filed by Drennan in the Twenty-Ninth Judicial District Court for the Parish of St. Charles, styled *Wallace C. Drennan, Inc. v. St. Charles Parish and V.J. St. Pierre in his capacity as President of St. Charles Parish*, No. 77453 c/w 77452 ("the Ordinary Proceeding"), and that the Ordinary Proceeding will proceed as plead.

CHANGE ORDER

- 1. Deleted Work Items: No work was performed under this item
- 2. Add the Following Work Items:
 - a The 6-inch barrier curb was added to protect the water mains.
 - b The 6-inch barrier curb was added to protect the water mains.

 - d Additional layout was performed in various streets to avoid conflicts with existing utilities
 - e We received our notice to proceed on October 24, but we were unable to begin work until November 4 due to the limits of the servitude agreements were not received and the direction from the Parish on the water main offset elevations were not received until November 4.
 - f due to replacement of culverts at 134 Bayou South This work resulted in additional excavation and trucking to haul off the old culvert, concrete and fine grading for the driveway. This work had to be done in order to complete base course installation, fine grading and formwork for the roadway. The Parish directed us to raise the invert elevation of box culvert approximately one foot from the original plan elevation. This direction came after the waterline offset was installed at the elevation provided to
 - accommodate the original plan elevation of the box culvert. The new box culvert elevation resulted in the need redo the offset and raise the waterline to eliminate the conflict with the new box culvert
- 3. Revise the following Work Item Quantizes:
 - a. The resident on Matherne Dr. requested the mound of dirt be removed to the fence. SCP requested the dead tree on Matherne Dr. be removed before it fell into the canal. SCP requested the rotten water main supports be replaced on Matherne Dr.
 - b. The 36-inch drain line on Pleasant Valley was rerouted to avoid conflict with the south headwall. The 24-inch pipe was changed to plastic pipe on Pleasant Valley
 - c. SCP requested the 24-inch drain pipe under the driveway at 139 Dixie Dr. be removed & replaced.
 - d. Credit for the sewer manhole and the catch basin that was not used.
 - e. To tie-in the existing paving at an approved location, the paving limits were extended.
 - f. To insure proper drainage, the elevations and the length of the restoration limits were extended.
 - g. To tie-in the existing paving at an approved location, the paving limits were extended.
