We appreciate your consideration of this request and will forward our comments to you as soon as possible.

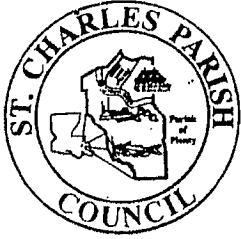

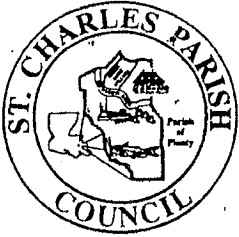
