ORDINANCE NO. 01-1-9

An ordinance to approve the resubdivision of Parcel Z, Ormond Country Club Estates, containing Parcels 1, 2, and 3, Section 5, being a portion of Ormond Plantation Sections 14, T12S R8E of the Mississippi River into Cypress Cove Subdivision, Phase I, Lots 1-7, St. Charles Parish, La. as requested by Paul J. Murray, Jr., June Murray, Paul J. Murray III, and Stacy S. Murray.

WHEREAS, Paul J. Murray, Jr., June Murray, Paul J. Murray III, and Stacy S. Murray own an undeveloped tract of land in Destrehan, La; and,

WHEREAS, the owners wish to subdivide the identified tract for future development; and,
