An ordinance approving and authorizing the execution of an Act of Dedication for Ormond Country Club Estates, Section 12, Phase D-2 Subdivision, St. Charles Parish, LA.

WHEREAS, a resubdivision of Parcels 11-A & 11-B into Parcel SCP, Sq. A, Lots 110-140; Sq. B, Lots 238 - 267, Sq. C, Lots 206 - 212, the dedication of portions of Nottaway Drive, Madewood Drive, and Arlington Drive, of Entergy & drainage servitudes and revocation of drainage servitudes; and,

WHEREAS, said subdivision has been constructed in accordance with the St. Charles Parish Subdivision Regulations of 1981, as amended; and,

WHEREAS, all required administrative reviews and approvals have been effected relative to said subdivision.

# THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the attached Act of Dedication for Ormond Country Club Estates, Section 12, Phase D-2 Subdivision which Parcel SCP, Sq. A, Lots 110-140; Sq. B, Lots 238 - 267, Sq. C, Lots 206 - 212, the dedication of portions of Nottaway Drive, Madewood Drive, and Arlington Drive, of Entergy & drainage servitudes and revocation of drainage servitudes is hereby approved and accepted.

SECTION II. That the Parish President is hereby authorized to execute the attached Final Plat and Act of Dedication on behalf of St. Charles Parish.

**BEFORE US**, the undersigned Notaries Public, duly commissioned and qualified in and for the Parishes and State as hereinafter set forth, and before the undersigned competent witnesses,

## PERSONALLY CAME AND APPEARED:

THE MITCHELL COMPANY, INC., an Alabama corporation, duly authorized to do business in the State of Louisiana, appearing herein through its agent, duly authorized by virtue of a resolution of the Board of Directors of said corporation, a copy of which is annexed hereto;

(hereinafter referred to as "Mitchell")

Mitchell declared unto me, Notary, that is the owner of a certain tract of immovable property situated on the East Bank of St. Charles Parish, which land is designated as ORMOND COUNTRY CLUB ESTATES, SECTION 12, PHASE D-2 ("ORMOND PHASE D-2"), being a portion of Sections 14 and 15, Township 12 South, Range 8 East, and Sections 3 and 4, Township 13 South, Range 8 East, St. Charles Parish, Louisiana, as shown on a survey of said subdivision prepared by Ronald Clement, Land Surveyor, dated April 4, 2003, a copy of which survey is attached hereto and made a part of this Act of Dedication; and

Mitchell further declared unto me, Notary, that it has caused a portion of the above property designated as LOTS 110 through 140, SQUARE A, LOTS 238 through 267, SQUARE B and LOTS 206 through 212, SQUARE C, on the survey referred to above to be laid out into lots, in order to create ORMOND PHASE D-2; and

Mitchell further declared unto me, Notary, that on the aforesaid plan of resubdivision, it has laid out certain streets within ORMOND PHASE D-2, which are named and identified as a portion of MADEWOOD DRIVE, ARLINGTON DRIVE AND NOTTAWAY DRIVE, in regard

to this dedication are more fully described in Exhibit "A" attached hereto and made a part hereof.

On all matters of the description of the property on which the streets above named are located, the attached survey shall be controlling.

Mitchell further declared unto me, Notary, that on the aforesaid plan of resubdivision, it has also designated and labeled various servitudes for water, utility and drainage purposes; and

Mitchell further declared unto me, Notary, that under the covenants, conditions and stipulations hereinafter recited it does by these presents, dedicate the following streets located all within ORMOND PHASE D-2, namely: a portion of MADEWOOD DRIVE, ARLINGTON DRIVE AND NOTTAWAY DRIVE, as hereinabove described and does hereby grant the various servitudes for water, utility and drainage purposes, all as shown on the annexed plan of subdivision, to public use, unto and in favor of the Parish of St. Charles, the inhabitants of the Parish of St. Charles, and to the public in general; and

Mitchell further declared unto me, Notary, that the aforesaid dedication and grant is subject to all the following terms and conditions, to-wit:

- 1. The dedication of the fee ownership of the property to the Parish of St. Charles is covered by the street identified hereinabove as a portion of MADEWOOD DRIVE, ARLINGTON DRIVE AND NOTTAWAY DRIVE, but only as far as said streets are located in ORMOND PHASE D-2.
- 2. The herein grant of the various servitudes for water, utility and drainage purposes shall constitute the granting only of a personal servitude of right of use being a "limited personal servitude" in favor of St. Charles Parish. Mitchell does hereby reserve all rights of fee ownership to that portion of the aforesaid ORMOND PHASE D-2, which comprises the various servitudes for water, utility and drainage purposes.
- Mitchell does hereby reserve all rights of ownership to all of the oil, gas 3. and other minerals in, on and under the property covered and affected by the streets identified hereinabove and by the aforesaid water, utility and drainage servitudes granted herein. In that connection, Mitchell does, however, agree to prohibit the use of any part of the surface of any of the property covered by the street and servitudes with respect to the exploration, development of production of minerals pursuant to this reservation. This reservation is made in accordance with Mitchell's plan and intention to reserve all of the mineral rights in, on and under all of the lots in ORMOND PHASE D-2, whereby, however, Mitchell will likewise impose a restriction on the entire subdivision against any use of the surface of any lot for exploration, development or productions of minerals, pursuant to this reservation. This reservation is made in accordance with Mitchell's plan and intention to reserve all of the mineral rights in, on and under all of the lots in ORMOND PHASE D-2 whereby, however, Mitchell will likewise impose a restriction of the entire subdivision against any use of the surface of any lot for the exploration, development or production of

- minerals, or by any other binding means of strict surface operations in regard to mineral exploration in this subdivision.
- 4. The herein dedication of street and grant of servitudes for water, utility and drainage purposes are made by Mitchell without any warranty whatsoever except as provided for herein.
- 5. St. Charles parish must bind and obligate itself not to use the property dedicated herein for street purposes in any manner, which would be inconsistent with or detrimental to such uses as a public street. St. Charles Parish must further bind and obligate itself to use the water, utility and drainage purposes.
- 6. This dedication and grant are conditioned upon St. Charles Parish maintaining and policing the streets dedicated herein and maintaining the various water, utility and drainage facilities with the various water, utility and drainage servitudes areas.
- 7. The grant herein of various servitudes for water, utility and drainage purposes shall be used exclusively for those purposes and Mitchell reserves the right to use or grant any other rights with respect to said property and inconsistent with the aforesaid servitudes for water, utility and drainage purposes. The herein granted water, utility and drainage servitudes shall not be utilized so as to unreasonably interfere with or impair ingress and egress from the street dedication herein to any of the lots in ORMOND PHASE D-2.
- 8. Mitchell warrants that the herein dedication of street and grant of servitudes are free of any liens and encumbrances and that no lots have been sold or alternated prior to the date hereof.
- 9. The dedication and grant made herein are made subject to any existing servitudes affecting ORMOND PHASE D-2 such as by way of illustration, but not limitation, pipeline servitudes and levees.
- 10. The herein dedication and grant shall inure to the benefit of St. Charles Parish or any successor governmental body of St. Charles Parish, which shall be bound by all of the terms and conditions hereof.
- 11. Mitchell declares that all utilities and streets have been placed within the streets and servitude areas and warrants that all utilities and streets have been placed within the servitude(s) granted herein.

AND NOW, into these presents, personally came and intervened:

ST. CHARLES PARISH, herein appearing by and through Albert D. Laque, Parish President, duly authorized by virtue of an Ordinance of the St. Charles Parish Council adopted on 0 cho bec 20, 2003, a certified copy of which is annexed hereto and made a part hereof,

and said St. Charles Parish does hereby accept, approve and ratify the herein dedication and grant under all of the terms and conditions as contained hereinabove, and does also hereby acknowledge that the construction of the streets dedicated herein has been satisfactorily completed in accordance with all requirements and that all water, utility and drainage facilities have been likewise

satisfactorily completed in accordance with all requirements, and St. Charles Parish does hereby accept all of said street and water, utility and drainage facilities and assumes the maintenance thereof.

This Act of Dedication and Acceptance was approved and accepted by the St. Charles Parish Council by Ordinance No.03 (0-12 on the 26 day of October, 2003, a photocopy of which is attached and made a part hereof.
