Grants Office Facts

- Pursue grant funding and manage grant awards for Parish projects and programs
- \$95M in grants awarded for 156 projects and programs since 2008
 - \$74M in competitive grant awards
 - \$16M in non-competitive grant awards
 - \$5M in FEMA Public Assistance
 - That's over \$1,800 in grant funding per parish resident!
- Completed 96 grant projects costing \$71M since 2008
 - \$57M in grant funding utilized
 - Only \$14M in local funds utilized
 - That's over \$4 in grant funding for every \$1 of local funds!
- Grants Office 2015 Budget \$286K



Public Assistance

- The Grants Office prepares and submits Requests for Public Assistance to FEMA during emergency/disaster events.
- Generally 75% Federal Share
- Applied for and received State of Louisiana Insurance Commissioner's Certification in February 2015 – waives \$141K in insurance deductions imposed by FEMA for Hurricane Issac based on the DAP9580.3.
