An ordinance approving and authorizing the execution of Change Order No. 1 (Final) for the Automated Water Meter Reading Installation Program (Project No. WWKS 106), to decrease the contract amount by \$124,520.00.

- WHEREAS, Ordinance No. 22-3-1 adopted on March 7, 2022, by the St. Charles Parish Council, approved and authorized the execution of a Professional Services Agreement with All South Consulting Engineers, LLC, to perform engineering services for the Automated Meter Reading Installation Program (Project No. WWKS 106), not to exceed \$414,093.00.; and,
- WHEREAS, Ordinance No. 23-2-2 adopted on February 6, 2023, by the St. Charles Parish Council, approved and authorized the execution of a contract with Pedal Valves, Inc. for the Automated Water Meter Reading Installation Program (Project No. WWKS 106) in the amount of \$687,155.00; and,
- **WHEREAS,** it is necessary to delete, deduct, and revise work item quantities to match the final work completed; and,
- **WHEREAS**, the revised work items results in a decrease in the Construction Contract amount of \$124,520.00.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That Change Order No. 1 (Final) for the Automated Water Meter Reading Installation Program (Project WWKS 106), to decrease to the contract amount of \$124,520.00 is hereby approved and accepted.

SECTION II. That the Parish President is hereby authorized to execute said Change Order on behalf of St. Charles Parish.

a. Contract Item: 3.0 Driveway Removal & Replacement

Delete item in its entirety. (-\$ 30,000.00)

2. Add the Following Work Items:

3. Revise the Following Work Item Quantities:

a. Contract Item #: 1.0 Remove & Install 5/8" X 3/4" Meter

The quantity is to be changed to 8,303 EA (-\$ 84,796.00).

b. Contract Item #: 2.0 Remove & Install 1" Meter

The quantity is to be changed to 611 EA (-\$ 2,726.00).

c. Contract Item #: 4.0 Meter Box Removal & Installation (include Lid)

The quantity is to be changed to 1,069 EA (+\$ 1,080.00).

d. Contract Item #: 5.0 Meter Lid Replacement Only

The quantity is to be changed to 409 EA (-\$ 8,078.00).

 - a. Item 3.0, *Driveway Removal & Replacement*, was removed from the project because the contractor did not need to replace any driveways while they were replacing water meters.
- 2. Add Work Items

 - a. Item 1.0, *Remove & Install 5/8" X 3/4" Meter*, was revised to subtract the remaining quantity from the project. The contractor had remaining quantity for this item when they reached the end of their scoped 5/8" X 3/4" meter replacements.
 - b. Item 2.0, *Remove & Install 1" Meter*, was revised to subtract the remaining quantity from the project. The contractor had remaining quantity for this item when they reached the end of their scoped 1" meter replacements.

- c. Item 4.0, *Meter Box Removal & Installation (include Lid)*, was revised to add quantity to pay for the number of removal and installed meter boxes. The contractor came across more broken water meter boxes than originally expected.
- d. Item 5.0, *Meter Box Lid Replacement Only*, was revised to subtract the remaining quantity from the project. The contractor had remaining quantity for this item when they reached the end of their scoped all scoped meter replacements.
