An ordinance to approve and authorize the execution of a contract with Barriere Construction Co., LLC for the construction of Parish Project No. P160302-6, Road Maintenance 2019, with Base Bid and Alternate No. 1, in the amount of \$1,247,333.00.

WHEREAS, Barowka and Bonura Engineers and Consultants, LLC, Consulting Engineers for the Project, have reviewed the bids and recommend that the Base Bid and Alternate No. 1, of the Contract be awarded to the low bidder, Barriere Construction Co., LLC, in the amount of \$1,247,333.00.

PLEASE TAKE NOTICE that by virtue of a written contract dated August 8, 2019, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, Larry Cochran, duly authorized by Ordinance No. 19-8-4, adopted by the St. Charles Parish Council on August 5, 2019, and Barriere Construction Co., L.L.C., P. O. Box 1576, Boutte, LA 70039, through Jason P. Latiolais, Vice President-Asphalt Operations, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a thorough and workmanlike manner: Road Maintenance 2019, Parish Project No. P160302-6, in St. Charles Parish, Louisiana for the price and sum of ONE MILLION TWO HUNDRED FORTY-SEVEN THOUSAND, THREE HUNDRED THIRTY-THREE DOLLARS AND 00/100 (\$1,247,333.00). The work under the Contract to be completed within Ninety (90) calendar days from the date of the Notice to Proceed.

The work of this contract comprises of improvements to asphalt roadways in St. Charles Parish. The work under this contract can be described as milling and overlay of asphalt, pavement patching, restoration of streets, and all incidental services thereto according to the Contract Documents prepared by Barowka and Bonura Engineers and Consultants, LLC, dated May 2019, and certified July 8, 2019. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

The property upon which the above described improvements are to be constructed is generally located on the East and West Banks of St. Charles Parish, Louisiana. All of the work of this Contract is located in rights-of-way owned and/or granted right to use by St. Charles Parish.
