ST. CHARLES PARISH, a political subdivision of the State of Louisiana, herein represented by V. J. St. Pierre, Jr., its Parish President, and whose mailing address is P. O. Box 302, Hahnville, Louisiana, 70057; and pursuant to Ordinance No. <u>08-8-6</u>, adopted by the St. Charles Parish Council on <u>August 18, 2008</u>, a copy of which is annexed hereto and made a part hereof,

hereinafter designated as "purchaser", here present, accepting and purchasing and acknowledging delivery and possession of the following described property, to-wit:

THAT PORTION OF GROUND, together with all the buildings and improvements thereon, and all of the rights, ways, privileges, servitudes, appurtenances and advantages thereunto belonging or in anywise appertaining, situated in the Parish of St. Charles, State of Louisiana, in Section 5, Township, 12 South, Range 8 East, in or near the Town of Norco, in what is known as Unit 1, Hiland Park Subdivision, as per plan by E. ## THIS SALE IS MADE SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS:

- 1. The property shall be dedicated and maintained in perpetuity for uses compatible with open space, recreational, or wetlands management practices; and
- 2. No new structure(s) will be built on the property except as indicated below:
  - (a) A public facility that is open on all sides and functionally related to a designated open space or recreational use;
  - (b) A rest room; or
  - (c) A structure that is compatible with open space, recreational or wetlands management usage and proper floodplain management policies and practices, which the Director approves in writing before the construction of the structure begins.
- 3. After completion of the project, no application for additional disaster assistance will be made for any purpose with respect to the property to any Federal entity or source, and no Federal entity or source will provide such assistance.
- 4. Fence encroachment as shown on survey by Gilbert, Kelly & Couturie, Inc., dated May 24, 1979.

To have and to hold the said property unto the said purchaser forever.
