ORDINANCE NO. 13-11-8

An ordinance to amend Ordinance No. 13-5-12, a Contract by and between the Parish of St. Charles and Science Applications International Corporation for Monitoring of Disaster Generated Debris & Disaster Management and Technical Services, Parish Project No. P090903, to consent to a business name change within the contract from Science Applications International Corporation to Leidos, Inc.

**WHEREAS,** the St. Charles Parish Council adopted Ordinance No. 13-5-12 on May 20, 2013, approving a Contract for the Monitoring of Disaster Generated Debris & Disaster Management and Technical Services, Parish Project No. P090903, with Science Applications International Corporation; and,

**WHEREAS,** effective September 27, 2013, Science Applications International Corporation changed its name to Leidos, Inc.; and,

**WHEREAS,** St. Charles Parish desires to consent to the name change within the Contract from Science Applications International Corporation to Leidos, Inc. and reiterate that Leidos, Inc. shall assume all of the rights, duties and obligations of Science Applications International Corporation arising out of the Contract.

**THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:**

**SECTION I.** That Amendment No. 1 to Ordinance No. 13-5-12 is hereby accepted and approved to consent to a business name change within the Contract by and between the Parish of St. Charles and Science Applications International Corporation for the Monitoring of Disaster Generated Debris & Disaster Management and Technical Services, Parish Project No. P090903, from Science Applications International Corporation to Leidos, Inc.

**SECTION II.** That the Parish President is hereby authorized to execute said Amendment No. 1 on behalf of St. Charles Parish.

**AMENDMENT NO. 1  
TO  
CONTRACT  
BETWEEN THE PARISH OF ST. CHARLES AND  
SCIENCE APPLICATIONS INTERNATIONAL CORPORATION FOR  
MONITORING OF DISASTER GENERATED DEBRIS REMOVAL AND DISASTER MANAGEMENT  
AND TECHNICAL ASSISTANCE SERVICES**

This Amendment to the Contract for Monitoring of Disaster Generated Debris Removal and Disaster Management and Technical Assistance Services ("Amendment") shall be effective **September 27, 2013**, by and between the **PARISH OF ST. CHARLES** ("OWNER") and **LEIDOS, INC.** ("CONTRACTOR"), formerly known as Science Applications International Corporation.

**Recitals**

**WHEREAS**, OWNER entered into a Contract on May 20, 2013, approved and authorized by St. Charles Parish Council Ordinance No. 13-5-12, for Monitoring of Disaster Generated Debris Removal and Disaster Management and Technical Assistance Services ("Contract") with Science Applications International Corporation, Parish Project No. P090903;

**WHEREAS**, effective September 27, 2013, Science Applications International Corporation changed its name to Leidos, Inc.;


**WHEREAS**, OWNER and CONTRACTOR desire to set forth herein the name change and reiterate that CONTRACTOR shall assume all of the rights, duties and obligations of CONTRACTOR arising out of the Contract; and

**NOW THEREFORE**, the parties hereby agree as follows:


1. Consent to Business Name Change. OWNER consents to CONTRACTOR's business name change within the Contract from Science Applications International Corporation to Leidos, Inc.
2. Modifications. This Amendment and the Contract, taken together, constitute the final Contract between OWNER and CONTRACTOR. Any modification of or additions to the terms of this Amendment or Contract must be in writing and executed by the parties. Except as specifically modified hereinabove, all of the remaining terms and conditions of the Contract shall remain in full force and effect.
