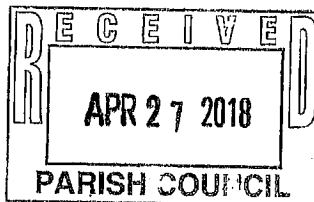

If the Registrar of Voters has not been previously contacted regarding this election, this is to advise that it will be necessary for you to furnish the precinct registers for use on election day.


