- WHEREAS, effective September 27, 2013, Science Applications International Corporation changed its name to Leidos, Inc.; and,
- WHEREAS, the St. Charles Parish Council adopted Ordinance No. 13-11-8, approving and authorizing Amendment No. 1 to said Contract November 18, 2013, to consent to the name change from Science Applications International Corporation to Leidos, Inc., and reiterate that Leidos, Inc., shall assume all of the rights, duties and obligations of Science Applications International Corporation arising out of said Contract;
- WHEREAS, effective August 23, 2014, Tetra Tech, Inc., acquired the assets of the BDR Division of Leidos, Inc., which includes performance obligations under said Contract; and,
- WHEREAS, St. Charles Parish desires to consent to the business name change within the Contract from Leidos, Inc., to Tetra Tech, Inc., and reiterate that Tetra Tech, Inc., shall assume all of the rights, duties and obligations of Leidos, Inc., arising out of the Contract.

AMENDMENT NO. 2

TO

CONTRACT

BETWEEN THE PARISH OF ST. CHARLES AND LEIDOS, INC., FOR MONITORING OF DISASTER GENERATED DEBRIS REMOVAL AND DISASTER MANAGEMENT AND TECHNICAL ASSISTANCE SERVICES

This Amendment to the Contract for Monitoring of Disaster Generated Debris Removal and
Disaster Management and Technical Assistance Services ("Amendment") shall be effective
March 18 2015 , by and between the PARISH OF ST. CHARLES ("OWNER") and
TETRA TECH, INC., the successor in interest to the BDR Division of LEIDOS, INC., formerly
SCIENCE APPLICATIONS INTERNATIONAL CORPORATION ("CONTRACTOR").

Recitals

WHEREAS, OWNER entered into a Contract on May 20, 2013, approved and authorized by St. Charles Parish Council Ordinance No. 13-5-12, for Monitoring of Disaster Generated Debris Removal and Disaster Management and Technical Assistance Services ("Contract") with Science Applications International Corporation, Parish Project No. P090903;

WHEREAS, effective September 27, 2013, Science Applications International Corporation changed its name to Leidos, Inc.;

WHEREAS, the St. Charles Parish Council adopted Ordinance No. 13-11-8, approving and authorizing Amendment No. 1 to said Contract on November 18, 2013, to consent to the name change from Science Applications International Corporation to Leidos, Inc., and reiterate that CONTRACTOR shall assume all of the rights, duties and obligations of CONTRACTOR arising out of said Contract;

WHEREAS, effective August 23, 2014, Tetra Tech, Inc., acquired the assets of the BDR Division of Leidos, Inc., which includes performance obligations under said Contract;

WHEREAS, OWNER and CONTRACTOR desire to set forth herein the company change and reiterate that CONTRACTOR shall assume all of the rights, duties and obligations of CONTRACTOR arising out of said Contract; and,

NOW THEREFORE, the parties hereby agree as follows:

- 1. <u>Consent to Assignment</u>. OWNER consents to CONTRACTOR's business name change within the Contract from Leidos, Inc., to Tetra Tech, Inc.
- 2. <u>Modifications</u>. This Amendment, Amendment No. 1, and the Contract, taken together, constitute the final Contract between OWNER and CONTRACTOR. Any modification of or

additions to the terms of this Amendment, Amendment No. 1, or Contract must be in writing and executed by the parties. Except as specifically modified hereinabove, all of the remaining terms and conditions of the Contract shall remain in full force and effect.
