- WHEREAS, St. Charles Parish, in conjunction with the Judges of the 29th Judicial District, the Sheriff's Office, District Attorney's Office and the Schools Drug Free Program applied for a Juvenile Accountability Incentive Block Grant through the Louisiana Commission on Law Enforcement and Administration of Criminal Justice to develop and administer accountability - based sanctions for juvenile offenders; and,
- WHEREAS, on October 14, 1999 the Parish was notified that the Commission had approved the Grant in the amount of \$78,176.00 (Federal Share) with a local cash match of \$8,689.00; and,
- WHEREAS, the application designated the Center for Family and Youth Services, Inc. as the implementing agency for the Grant; and,
- WHEREAS, it is the desire of the Parish and the Center for Family and Youth Services to enter into an agreement for the implementation of Subgrant Number A98-8-028.

#### <u>WITNESSTH</u>

- WHEREAS, St. Charles Parish, in conjunction with the Judges of the 29th Judicial District, the Sheriff's Office and the Schools Drug Free Program applied for a Juvenile Accountability Incentive Block Grant through the Louisiana Commission on Law Enforcement and Administration of Criminal Justice to develop and administer accountability-based sanctions for juvenile offenders; and,
- WHEREAS, on October 14, 1999 the Parish was notified that the Commission had approved the Grant in the amount of \$78,176.00 (Federal Share) with a local cash match of \$8,689.00; and,
- WHEREAS, the application designated the Center for Family and Youth Services, Inc. as the implementing agency for the Grant; and,
- WHEREAS, it is the desire of the Parish and the Center for Family and Youth Services to enter into an agreement for the implementation of Subgrant Number A98-8-028.

## NOW, THEREFORE, IT IS HEREBY AGREED THAT:

Center for Family and Youth Services, Inc. shall:

- 1) Develop and administer accountability-based sanctions for juvenile offenders.
- 2) Address the problems of:
  - a) School Truancy and Absenteeism monitor attendance by obtaining records, site visits, meetings with attendance clerks and providing emergency assistance as needed.
  - b) Drugs weekly visits with probationist and drug testers.
  - c) Vandalism organize community education programs on the effects of vandalism, supervise community service clean-up projects and helping the elderly.
  - d) Curfew and Violence monitor compliance with court order conditions of probation.
  - e) Ungovernable coordinate training for families, and monitor compliance with counseling as ordered by the court.
  - f) Runaways mandatory counseling on a regular basis.
  - g) Theft organize community education programs on the consequences of theft and supervise community service clean-up program.

- 3) Implement the grant in accordance with the rules, regulations, procedures, and guidelines of the Louisiana Commission on Law Enforcement and Administration of Criminal Justice applicable to Subgrant Number A98-8-028 including the submission of Quarterly Progress Reports.
- 4) Comply with all provisions of the Statement of Subgrant Award #A98-8-028 and the conditions of the Subgrant Application including all audit requirements.
- 5) Reimburse St. Charles Parish for any disallowed grant expenditures required to be returned to the Commission.

#### St. Charles Parish shall:

- 1) Administer the funds of Louisiana Commission on Law Enforcement and Administration of Criminal Justice Subgrant Number A98-8-028.
- 2) Make payment for all expenses incurred in accordance with the rules, regulations, procedures, guidelines and special conditions of the Grant, not to exceed \$86,865.00 (\$78,176.00 Federal Funds and \$8,689.00 Local Funds).
- 3) Maintain the right to examine the financial and program records of the Center for Family and Youth Services, Inc.
