ORDINANCE NO. 10-7-4

An ordinance to amend Ordinance No. 93-4-22, to provide for the clarification of "Stop" signs on Third Street and Fourth Street at the front and rear of Fifth African Baptist Church in St. Rose.

WHEREAS, on April 19, 1993, the St. Charles Parish Council adopted Ordinance No. 93-4-22 which authorized the installation of "Stop" signs on Third Street and Fourth Street at the front and rear of Fifth African Baptist Church in St. Rose; and,

WHEREAS, the St. Charles Parish Code of Ordinances, Chapter 15 Motor Vehicles and Traffic provides for the installation of traffic control signs; and,

WHEREAS, it is the desire of the Parish Council to authorize the clarification of "STOP" signs placed on Third Street and Fourth Street at the front and rear of Fifth African Baptist Church in St. Rose.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That "STOP" signs shall be installed as follows:

- 1) **Third Street, St. Rose:**
 - a) One (1) sign facing North at the rear of Fifth African Baptist Church
 - b) One (1) sign facing South at the front of Fifth African Baptist Church
 - c) One (1) sign facing North at the front of Fifth African Baptist Church
- 2) **Fourth Street, St. Rose:**
 - a) One (1) sign facing South at the front of Fifth African Baptist Church
 - b) One (1) sign facing North at the rear of Fifth African Baptist Church
 - c) One (1) sign facing South at the rear of Fifth African Baptist Church

SECTION II. That the Department of Public Works is hereby authorized to erect and maintain said "STOP" signs.

The foregoing ordinance having been submitted to a vote, the vote thereon was as follows:
