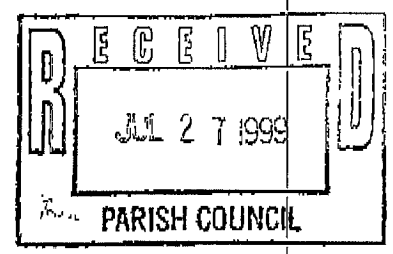

SUMMARY NO. 4761 (7-6-99/C. Tregre)

An ordinance to amend the Zoning Ordinance of 1981, Ordinance No. 81-10-6, adopted October 19, 1981 to approve the change of zoning classification from R-1A and C-3 to R-1M at property located on the east side of Thelma Drive, Hahnville, La. as requested by Davis Nicholas, Jr.
