An ordinance to provide for the installation of "**ALL-WAY STOP**" signs at the intersection of Cove Pointe Drive and Cove Glen Lane, in Ashton Plantation Subdivision in Luling.

WHEREAS, the St. Charles Parish Code of Ordinances, Chapter 15 Motor Vehicles and Traffic provides for the installation of traffic control signs; and,

WHEREAS, the installation of "All-Way Stop" signs will significantly reduce the possibility of accidents at this intersection by mitigating the risk navigating at the intersection on Cove Pointe Drive and Cove Glen Lane; and,

WHEREAS, it is the desire of the Parish Council to authorize the installation of "**ALL-WAY STOP**" signs at the intersection of Cove Pointe Drive and Cove Glen Lane, in Ashton Plantation Subdivision in Luling due to safety concerns.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That there is hereby established "**ALL-WAY STOP**" signs at the intersection of Cove Pointe Drive and Cove Glen Lane, in Ashton Plantation Subdivision in Luling.

SECTION II. That the Department of Public Works is hereby authorized to erect and maintain said "**ALL-WAY STOP**" signs.
